The personal data that Kussengevecht processes:

Kussengevecht processes your personal data because of the services Kussengevecht provides and/or because you shared your personal data with us.

Below is an overview of the personal data we process:

- First and last name
- Gender
- Date of birth
- Address
- Phone number
- E-mail address
- Bank account number

Special and/or sensitive personal data that we process:

Our website and/or service does not intend to collect data about website visitors who are younger than 16 years old unless they have permission from parents or guardians. However, we have no means to check if a visitor is older/younger than 16 years. We therefore advise parents to be involved in their kids online activities in order to prevent data about minors being collected without parental consent. Why we process personal data:

Kussengevecht processes your personal data for the following purposes: -

Handling your payment.

- Performing our services.
- Kussengevecht also processes personal data that we are legally obliged to do so. (Government: Hotel Registration and Tax Office)

Kussengevecht does not use personal data for advertising purposes and/or newsletters.

Automated decision-making:

Kussengevecht does not make decisions about matters that can have (significant) consequences for people based on automated processing.

For how long we store your personal data:

Kussengevecht does not keep your personal data longer than is strictly necessary to achieve the goals for which your data is collected. We store personal data for the following categories only:

- First and last name: 10 years, Tax Office
- Gender: 7 years, Hotel Register
- Date of birth, 1 year, own use
- Address details, 7 years, Hotel Register
- Telephone number, 1 year, own use
- E-mail address, 1 year, own use
- Bank account number, 10 years, Tax Office

#### Sharing personal data with third parties:

Kussengevecht provides your personal data exclusively and only to third parties if necessary for the execution of our agreement with you, or to comply with a legal obligation.

#### Cookies or similar techniques:

The Kussengevecht website itself does not use cookie files that map and store your personal data. Kussengevecht collects only static market data, analytical data which can not be traced back to concrete address data. No personal data about surfing behavior and website visits is stored by the website kussengevecht.nl

A booking request filled out by you on the website Kussengevecht is directly delivered to the by Google secured mailbox of weimarstraat@gmail.com

#### View, modify or delete data:

You have the right to view, correct or delete your personal data.

This removal does not relate to your data, which, as a result of a specific booking by you, is subject to the obligation to retain from the government (the Hotel Register for 7 years and the Tax Office for 10 years). In addition, you have the right to withdraw your consent to the processing of your personal data by Kussengevecht and you have the right to data portability.

This means that you can submit a request to us for the personal data we have stored in our files to have it send to you or any organization you mentioned.

You can request a viewing, correction, deletion, data transfer of your personal data or request to withdraw your consent or objection to the processing of your personal data by sending a message to weimarstraat@gmail.com.

In order to ensure that the request for access has been made by you, we will ask you for proof of identity. Make your passport photo black in the image you send us, and make black the MRZ (machine readable zone, the strip with numbers at the bottom of the passport), the passport number and the citizen service number (BSN) too. This is in order to protect your privacy. We respond as quickly as possible to your request (within four weeks)

Kussengevecht also wants to point out that you have the possibility to file a complaint with the national supervisor, the Dutch Data Protection Authority. This can be done via the following link:
